

REGISTRATION STATEMENT FOR MR. JULIUS B. SEFFU

Item 4: Describe fully the nature and method of performance of the above indicated agreement or understanding.

The registrant has been appointed and authorized by Resistencia Nacional Mocambicana, RENAMO, to act as its Representative and its Spokesman to the United States. Specifically, the registrant's responsibilities will include (1) contacting government officials and members or committees of the Congress on policy matters on behalf of RENAMO; (2) making statements on RENAMO's behalf and presenting RENAMO's position to all sections of the public within the United States with respect to matters of political concern to RENAMO; and (3) advising and informing all sections of the public within the United States with respect to the political policies, interests, and relations of RENAMO and the political, social, and economic facts and conditions of Mozambique. In carrying out these responsibilities, the registrant anticipates that he will give speeches and grant interviews and prepare and disseminate statements and supporting documents for presentation to, and arrange conferences with, various sections of the public within the United States.

The registrant's agreement to act as RENAMO's Representative and Spokesman to the United States is of indefinite duration. The registrant anticipates receiving fees or expenses from RENAMO as and when funding is available. The registrant also anticipates receiving contributions, loans, money, and other things of value from private sources within the United States, either as reimbursement for expenses incurred by the registrant or for disbursement by the registrant in furtherance of or in connection with his activities on behalf of RENAMO. The registrant may seek contributions, loans, money, and other things of value, as part of a fund-raising campaign, for or in the interests of RENAMO.
