

Commencing on October 1st, 1990, IBUSZ Hungarian Travel Company entrusts Peter Gomori to open and direct its Midwest Office in Chicago for a period of 4 years. It will be Peter Gomori's responsibility to promote Hungary as a tourist destination to the American tour operators and travel agents as well as provide general information to the traveling public. IBUSZ will pay Peter Gomori 2,300 US \$ salary per month, maintain an apartment and a company car as well as furnish free air tickets between Chicago-Budapest on at least two occasions per year.


5. Describe fully the activities the registrant engages in or proposes to engage in on behalf of the above foreign principal.
