



ASL International will advise and represent Sekur-Pirelli for a 90 day period beginning on November 1, 1991, ending on January 31, 1991.

The primary purpose of this advice and representation will be to assist Sekur-Pirelli in limiting or eliminating the injurious language contained in the Senate Committee report on the Defense Appropriations Bill for 1992 that extends the requirement to purchase American-made textile products to fuel containers for military aircraft. Additional assignments may be also undertaken that may be assigned under the provisions of this agreement.

While the primary responsibility for this advice and representation will fall on the signatories of this agreement for ASL International, other persons associated with ASL International may be utilized if their involvement serves the interest of Sekur-Pirelli.


In return for this advice and representation, Sekur-Pirelli agrees to pay ASL International a fee of \$ 30,000, paid in three montly instalments invoiced separately. This fee includes incidental expenses, but does not include major expenses such as travel. No major expenses will be incurred without the permission of Sekur-Pirelli.


This agreement may be extended by Sekur-Pirelli to cover a twelve month period beginning on November 1, 1991 and ending on October 31, 1992 at a fee of \$ 30,000 per quarter.
