An oral agreement was reached between Campbell, Falk and Selby and the Republic of Azerbaijan whereby the firm would contact Congressional staff regarding provisions in the Freedom Support Act. The initial agreement was for the duration of the legislation with compensation to be in the form of a monthly fee, at the suggested rate of \$5,000 per month.

4. Describe fully the nature and method of performance of the above indicated agreement or understanding.

Mr. Selby from the firm met with Ambassador Hasan Hassanov of the Republic of Azerbaijan. The Ambassador asked for the firm's assistance and directed Mr. Selby to begin work pending a formal, written agreement to be finalized at a later date.
