



C O N T R A C T

This Contract, made this 24th day of March, 1993, by and between the Government of the Republic Bophuthatswana (hereinafter "the Government") and Szlavik, Hogan & Miller, Inc. (herein called "SH&M"), a corporation organized and existing under the laws of the Commonwealth of Pennsylvania in the United States of America:

WITNESSETH:

WHEREAS, SH&M has submitted to the Government a number of proposals aimed at fostering closer ties between the people and governments of the United States and the Republic of Bophuthatswana; and

WHEREAS, the Government has accepted in principle certain concepts embraced in the proposals; and

WHEREAS, the Government wishes to retain the services of SH&M to assist, plan, develop, and execute certain programs set forth in the proposals; and

WHEREAS, the Government and SH&M, in order to assure a continuing harmonious relationship, wish to reduce to writing the terms and conditions of their agreement.

NOW, THEREFORE, in consideration of the foregoing premises and the mutual covenants contained herein, the Government and SH&M hereby agree:

I. RETAINER

The Government hereby retains SH&M for the term and upon the terms and conditions hereinafter set forth; and SH&M accepts such retainer.

II. SERVICES

SH&M undertakes to provide the following services for and on behalf of the Government:

(1) *Governmental & Public Affairs.* SH&M shall be responsible for making available to appropriate key officials of the U.S. Government, non-governmental organizations, and to members of the U.S. Congress and their staffs information of mutual interest and concern to the Government of the United States, non-governmental organizations, and to the Government. SH&M shall represent and advocate to these officials and staff persons matters of interest to the Government, particularly issues, programs and projects in which the Government is participating or wishes to further develop or become eligible.

(2) *Media & Communications Consulting.* SH&M shall serve as an authorized contact of the Government with representatives of the news media for the purpose of providing information deemed important by appropriate officials of the Government and of processing inquiries from the media relevant to matters of concern to and about the Republic of Bophuthatswana. SH&M, upon request, shall be responsible for the design, production and placement of any communication materials deemed necessary by appropriate officials of the Government, provided that expenses so incurred for said production and placement shall be subject to the provisions regarding expenses of the hereinafter Section, "PAYMENT."

(3) *Commerce-Trade & Investment Promotion.* SH&M shall work to design, promote, assist and execute programs and materials to inform the American business community about the investment, trade, and economic opportunities the Government and it's members are encouraging to increase bilateral economic relations, joint ventures, commerce and trade with the Republic of Bophuthatswana.

III. REPORTS

On or before the 10th day of each month, SH&M shall submit a written report of its activities for the previous month to a designated official of the Government. SH&M, upon request by the designated official of the Government, shall at any other time submit reports concerning issues relevant to its services.

IV. PAYMENT

The Government undertakes and hereby agrees to pay or cause to be paid to SH&M in consideration of the aforementioned covenants of this Contract the sum of Fifty Three Thousand Four Hundred dollars (\$53,400) for a six month period. A retainer fee of Twenty Six Thousand Seven Hundred dollars (\$26,700) for the first three months will be required on the day of signing. Thereafter, Eight Thousand Nine Hundred dollars (\$8,900) will be due on the third day of each month thereafter.

Any expenses, which shall be incurred only upon the request and approval of the designated official of the Government, such as travel, printing, entertainment, mailings, etc., shall be the sole responsibility of the Government. SH&M shall arrange for such expenses to be billed directly to the Government or shall bill the Government monthly for said expenses paid by SH&M.

If notice, demand or declaration of any kind is to be given by either party hereto, it shall be in writing. As utilized in this Contract, the term "in writing" shall mean a communication over an authorized signature, either by cable, telegram, or Telex, with confirmation copy by registered mail.

V. DURATION

Unless terminated sooner by either party providing to the other not less than thirty (30) days advance written notice of intent to terminate after the first three months, this Contract shall expire six months from the day and year first above written.

VI. APPLICABLE LAW

This Contract and the underlying commercial transaction shall be governed by the established general principles of private international law. It is understood and agreed upon by the parties hereto that at no time, in the performance of this Contract, will SH&M perform any act that is violative of any laws of or inimical to the interests of the United States.
