Government of Nicaragua: Samuels International Associates, Inc. provided advice, expertise and counsel to the Comision Nacional de Zonas Francas of the Government of Nicaragua concerning issues related to the implementation of the DR-CAFTA and evolving issues in U.S.-Nicaragua relations.

Government of Angola: Informed by the Embassy of Angola in January 2012 that the contract with Samuels International Associates was being suspended -- but not cancelled -- pending an administrative review by the Foreign Ministry, select services continued to be provided through a July 2012 visit by Ministry officials. Encouraged by meetings held, Samuels International Associates chose to wait an additional month concerning a formal modification to the consultant-client relationship. No further dialogue took place and the contract was considered terminated 30 August 2012.

Select services continued through a July visit by Ministry officials. Encouraged by meetings held, Samuels International Associates chose to wait an additional month concerning a formal modification to the consultant-client relationship. No communications took place. The contract was considered terminated 30 August.
