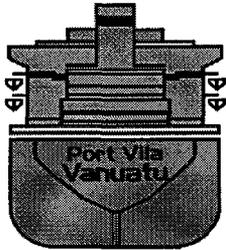

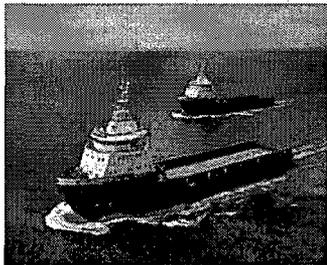

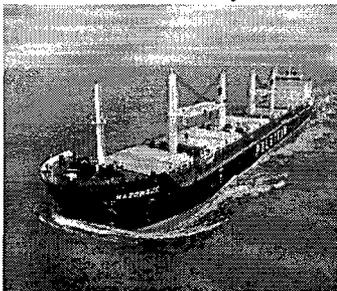

ILO MLC2006

The Maritime Labor Convention (2006) will come into force on 20 August 2013. If your vessel will be calling in a country that has ratified the convention after that date, your vessel must be in compliance. VMSL-NY has issued its DMLC 2006 Part I as well as its Maritime Bulletin #112 outlining its policy and instructions. Both have been placed on the website for your convenience.
