

As stated in the attached letter of authorization signed by the principal, the registrant has agreed to register as foreign agents for the Ministry of Defense for the Republic of Croatia, as their representatives and the Principal has also agreed to this. The registrant has agreed to act as a broker for the Principal and be compensated for those services provided.

5. Describe fully the activities the registrant engages in or proposes to engage in on behalf of the above foreign principal.

The corporation named above as registrant (Global Enterprises Group, Inc.) will represent the Ministry of Defense of the Republic of Croatia as registered Foreign Agents. The primary purpose of the corporation will be to facilitate ,arrange, and expedite sales and shipments of goods and merchandise between the Republic of Croatia and U.S. companies and between the Republic of Croatia and Foreign companies. Global Enterprises Group, Inc. will, furthermore, limit business transactions to those goods and services not restricted by any U.S., or Internation Law, Embargo, or Trade Restriction in effect at the time of the transaction.

It is also believed that Global Enterprises Group Inc. will engage in lobbying efforts and political activity in the course of conducting business in the future.
