



We help tour operators and travel agencies to obtain information on tourist attractions, cultural events, historical sights and more.

Participated at IT&ME Travel Show in Chicago, IL in September 2007. This event is to promote Sweden as a meeting & incentive destination to the American Meeting and Incentive Market.

Participated at HX Travel Shows in San Francisco, CA in October and in Miami, FL in December. These travel shows are to promote Sweden as a travel destination to American consumers.

Participated at SITE SoCal conference in San Diego, CA in November. This event is to promote Sweden as a meeting & incentive destination to the American Meeting and Incentive Market.

Participated at VEMEX (VisitEurope Media Exchange) in New York and Toronto in November 2007 and in Palm Springs for the Travel Media Showcase in December. These events are to promote Sweden as a travel destination to the American press and media.

Participated at USTOA (United States Tour Operators Association) workshop in Cancun, Mexico in December. This workshop is to promote Sweden as a travel destination to American Tour Operators.

In addition, we visited a number of US Tour Operators and Meeting & Incentive Planners on sales calls throughout the year of 2007 to promote Sweden as a travel destination.
