This amount is spent for writing publicity material, - travel stories, travel items, information, itineraries, suggestions how to spend your time in Austria, what to see, etc., etc. . . furthermore for production costs of circular letters, mimeographed information sheets and mimeographed material mentioned above, mailing and handling of travel films.

In addition to the above we have an advertising budget of \$10,000 for winter sport promotion and \$24,000 for summer travel promotion.

All advertising is placed by a Vienna Advertising Agency and appears in publications (magazines, newspapers) here. The money is not transferred to us but paid directly from Vienna to the publications. For this reason we have not mentioned an advertising budget.
