Mr. Zagaris also monitored developments on the Foreign Account Tax Compliance Act.

On a pro bono basis for Invest Barbados Mr. Zagaris helped suggest potential attendees to a promotional program in New York on opportunities to invest in Barbados to be held on October 16, 2013.
