It discussed the D.C. tax haven law and its impact on the Caribbean. He sent the same piece initially to the Washington Post and the New York Times. He duly indicated at the bottom of the piece and filed a dissemination report with the Department of Justice with respect to the submission of the op-ed piece.

On December 3, 2015 Mr. Zagaris discussed with Audrey Winter, Assistant USTR, U.S. bilateral investment treaty.
