Embassy of Japan

11. I arrange a series of meetings for Embassy staff with US Congressional staff that allow each side to explain the respective positions of the both governments relating to current foreign issues that affect the US- Japan relationship. My role has been to facilitate these meetings, attend these meetings and write reports based on these meetings. Issues discussed including security issues in Asia, US - Japan cooperation and foreign affairs, trade and defense issues of current interest in Congress. Meetings were held on the following dates with the following individuals:

I facilitated a meeting for the Congressional Affairs Section of the Embassy with Chris Walker with Speaker Dennis Hastert on January 3, 2006. I did not attend this meeting.

12. During the reporting period, I telephoned Congressional staff to check on the possibility of future meetings with the Embassy and to ascertain the status of certain foreign policy issues affecting the United States and Japan and between the United States and Japan. My role in these conversations was to inquire about the status of legislation and policy issues that might come up in these future meetings so as to provide background to the Embassy.
