

Agreement for Professional Services


Plexus Consulting Group, LLC (hereinafter "Plexus") and The Minister of Fisheries on behalf of the Government of Iceland (hereinafter "The Minister") hereby agree to the following:

Beginning on May 1, 2000, Plexus will, as directed by The Minister, perform certain communications services relating to sustainable fisheries management.

As payment for these services, Plexus shall invoice the Minister a flat monthly fee (in U.S. funds) of \$15,000--an amount that represents at least 75 hours of work per month at the billing rate of our experienced professionals. If, by mid year, the average amount of work has exceeded or, alternatively, come under the estimated amount, Plexus will notify the Minister that future adjustments in the monthly budget may be required.

All necessary and reasonable business expenses incurred by Plexus on behalf of The Minister shall be fully reimbursable and will be itemised in an invoice to be rendered on the last day of each month. *Provided*, however, that any expenses in excess of \$2,500.00 (U.S.) shall be approved in advance by The Minister or his designee.

Either party to this Agreement may cancel the Agreement with 60 days advance notice in writing to the other. *Provided*, however, that any fees due to Plexus prior to and including the 60-day cancellation period shall be paid by The Minister.
