Report to the US Department of Justice April – September 2001 - Nigeria
By GoodWorks International, LLC – Registration Number: 5414

Political Activities:

Within the context of political activities in the U.S. on behalf of Nigeria, GoodWorks International, LLC did the following:

Arranged and held several in-person meetings and telephone conversations with the U.S. President, the Secretary of State, the National Security Advisor, the U.S. Under Secretary of State for African Affairs and other Special Advisors to the President, to discuss Nigeria's strategic importance to the U.S. Also, contacts were made with U.S. officials on various occasions to gain support and assistance for the two official visits to the U.S. by Nigeria's President in 2001.

Arranged for and held several meetings with members of the Congressional Black Caucus (CBC) to articulate and gather support for Nigeria's strategic importance to the U.S. This contributed to the public statement by the ranking member of the CBC on the Subcommittee for Africa to that effect.

Held several in-person meetings and telephone conversations with U.S. top officials following the September 11 events, to convey Nigeria's full commitment to work with the U.S. leadership in the fight against terrorism.

Arranged for a top-level presence by Nigeria at the inaugural events of the current U.S. administration. Several ministers from Nigeria attended the range of events. *Refer to point 15 (a) (2) of supplementary report for cost.*

Held several discussions with ranking member for the Banking Committee as part of the campaign to return all stolen monies from Nigeria's state coffers by previous leaders, and also to gain support for debt relief for Nigeria.

Arranged and held two prominent business promotion meetings – a dinner in New York City at the Waldorf Astoria and a luncheon at the Atlanta downtown Ritz Carlton Hotel. At both events, leaders from the U.S. business and financial communities were invited to meet the President of Nigeria with whom they exchanged views on business opportunities in Nigeria.

Held several discussions with the U.S. Trade Representative's Office, which led to Nigeria becoming signatory to the TIFA trade agreements with the U.S.

Arranged meetings with the executives of Bell South, Myrant, Halliburton and Terra Foods to promote targeted investments in Nigeria, specifically within the energy and agriculture sectors.

Arranged press for a press meeting (in New York city) with the Nigerian and South African Presidents to officially announce the gas-to-liquid project in Nigeria.

GoodWorks principals participated in the forums on Nigeria organized under the auspices of the Council on Foreign Relations.

Arranged for letter of invitation from Congresswoman Maxine Waters to President Jose Eduardo dos Santos for meeting with Congressional leaders during possible September visit to the US.

Arranged meeting among the US Special Advisor to the President, the Under Secretary of State for Africa and GoodWorks principals to discuss a possible meeting between President Bush and President dos Santos.

Conversations with National Security Council to discuss whether the current US administration possibility of meeting between U.S. President and Angolan President, following the terrorist attacks on September 11, 2001.

Conversations with US Trade Representative for Africa's office regarding Angola's application for AGOA benefits. Obtained clarification from the USTR-Africa regarding Angola's application for AGOA beneficiary status. Wrote out and submitted request for consideration on Angola's behalf.
