Nigeria

May 2002: Arranged separate meetings between US officials and two Nigerian high officials - Chief Economic Adviser to the President and CEO, National Planning Commission and for Principal Secretary to the President. They met with officials of the US departments of Commerce dealing with economical and political affairs.

May 2002: Meeting with Acting Director of the Office of American & African Affairs of the US Department of Energy. Discussion focused on DOE contact person in Nigeria working on increasing "megs" to 2000 by year 2003. Also addressed cooperation for capacity building for women, and improvement of transportation from rural areas to geopolitical centers.

May 2002: Meeting with Deputy Assistant Secretary for Africa & The Middle East of The US Department of Commerce. Stressed the need for a strong working relationship with Nigerian businesses to benefit both sides.

May 2002: Meeting with officials from the US Department of Transportation & Aviation; and of the US Office of International Aviation. Discussed overview of the current ground, air and marine transportation systems Nigeria, to assess ways for the FAA to effectively transport security equipment to Lagos and Abuja that will help improve the transportation and aviation system.

May 2002: Meeting with Desk Officer for Nigeria at the US Department of Treasury on Nigeria's current national budget and how by 2003, Nigeria hopes to resume implementation of the IMF recommendations.

May 2002: Meeting with Special Asst. to the President and Senior Director for African Affairs, National Security Agency to address matters related to Nigeria with respect to economic and political performance, and the need to battle corruption effectively.

Angola April – June 2002

General lobbying activities include sensitizing the U.S. administration of the positive changes in Angola's political landscape and the need for U.S. assistance to meet the humanitarian emergency challenges in Angola.

Encouraged strategic partnership between the U.S. and Angola (as well as other oil producing African countries), in light of a potential crisis in the Middle East.

Efforts to arrange meetings between members of the U.S. President, his cabinet members and the President of Angola at the Leon Sullivan Summit Dinner were stalled due to non-attendance by the latter.
