Over the reporting period, meetings and phone conversations were held with the Special Assistant to the President for African Affairs, Dr. Jendayi Frazier, Congressman Donald Payne, Congressman Jesse Jackson and Staff Assistants Noelle Lusane and Melvin Spence. The contacts made were related to the proposed US sanctions against Nigeria for providing asylum to President Charles Taylor of Liberia. The objective was to prevent sanctions that could have included suspension of all bilateral assistance to Nigeria from the US. GoodWorks President C. MASTERS addressed the Nigerian People's Forum in Atlanta in February 2004, on doing business in Nigeria.


