

Short-Form Registration Statement  
Pursuant to the Foreign Agents Registration  
Act of 1938, as amended

Each partner, officer, director, associate, employee, and agent of a registrant is required to file a short form registration statement unless he engages in no activities in furtherance of the interests of the registrant's foreign principal or unless the services he renders to the registrant are in a secretarial, clerical, or in a related or similar capacity.

Privacy Act Statement. The filing of this document is required by the Foreign Agents Registration Act of 1938, as amended, 22 U.S.C. § 611 *et seq.*, for the purposes of registration under the Act and public disclosure. Provision of the information requested is mandatory, and failure to provide this information is subject to the penalty and enforcement provisions established in Section 8 of the Act. Every registration statement, short form registration statement, exhibit, amendment, copy of informational materials or other document or information filed with the Attorney General under this Act is a public record open to public examination, inspection and copying during the posted business hours of the Registration Unit in Washington, DC. Statements are also available online at the Registration Unit's webpage: <http://www.fara.gov/>. One copy of every such document, other than informational materials, is automatically provided to the Secretary of State pursuant to Section 6(b) of the Act, and copies of any and all documents are routinely made available to other agencies, departments and Congress pursuant to Section 6(c) of the Act. The Attorney General also transmits a semi-annual report to Congress on the Administration of the Act which lists the names of all agents registered under the Act and the foreign principals they represent. Footnote: Political activity as defined in Section 1(o) of the Act means any activity which the person engaging in believes will, or that the person intends to, in any way influence any agency or official of the Government of the United States or any section of the public within the United States with reference to formulating, adopting, or changing the domestic or foreign policies of the United States or with reference to the political or public interests, policies, or relations of a government of a foreign country or a foreign political party.

*ADDENDUM TO SHORT-FORM REGISTRATION STATEMENT*

Question 11 – Services:

Government of India: The Short Form Registrant will engage in political activities relating to two areas: monitoring and advising on U.S. policymaking processes with regard to India, and arranging meetings between Indian and U.S. officials.

The means employed may include communications to, and meeting and briefings with, U.S. government officials and members of the U.S. media, as well as distribution of informational materials.

Kurdistan Regional Government (formerly known as Kurdish Democratic Party): The Short Form Registrant will engage in political activities relating to two areas: monitoring and advising on U.S. policymaking processes with regard to Kurdistan, and arranging meetings between Kurdish and U.S. officials.

The means employed may include communications to, and meeting and briefings with, U.S. government officials and members of the U.S. media, as well as distribution of informational materials.

State of Qatar: The Short Form Registrant will engage in political activities relating to two areas: monitoring and advising on U.S. policymaking processes with regard to the State of Qatar, and arranging meetings between officials from Qatar and U.S. officials.

The means employed may include communications to, and meeting and briefings with, U.S. government officials and members of the U.S. media, as well as distribution of informational materials.

Embassy of Poland: Generally speaking, the Short-Form Registrant will provide the foreign principal with guidance on foreign policy matters before the U.S. Government, focusing on the area of defense and military co-operation.

The means employed may consist of communications with and lobbying of Congress and departments of the Executive Branch, as appropriate.
