## SERVICES AGREEMENT

This is an agreement under which Orion Strategies LLC, 918 Pennsylvania Avenue SE, Washington, D.C., 20003, agrees to work with and through The Reffe Group, 3300 Lowell, Street NW, Washington, D.C., 2008 to perform services on behalf of the Ministry of Foreign Affairs of the Government of the Republic of Montenegro.

### EFFECTIVE DATE/TERM

The effective date of this agreement is November 1, 2010. The term of this agreement is 24 months, ending October 31, 2012. This agreement may be extended upon agreement by both parties.

### SCOPE

For the term of this contract, under the direction of The Reffe Group and/or officials of the Foreign Ministry of the Republic of Montenegro, Orion Strategies LLC will provide advice and consulting services concerning Montenegro's Euro-Atlantic aspirations, including candidacy for membership in the North Atlantic Treaty Organization (NATO). Services pursuant to this agreement will include, but not be limited to, advice, guidance, and support for strategic communications, public relations, advocacy, communicating developments in Montenegro to U.S. decision makers, and related activities in the United States and in Europe.

### COMPENSATION

During the term of this agreement, Orion Strategies LLC will be compensated at the rate of \$12,500 per month, payable quarterly, for a total of \$300,000.00. Additional expenses will be reimbursed only if approved in advance.
