### **SERVICES AGREEMENT**

This is an agreement under which Orion Strategies LLC agrees to perform services on behalf of the Embassy of Japan, 2520 Massachusetts Ave. NW, Washington D.C., 20008.

#### **EFFECTIVE DATE/TERM**

The effective date of this agreement is October 27, 2014. The term of this agreement is 5 months and 1 week, ending March 31, 2015. This agreement may be extended upon agreement by both parties.

#### **SCOPE**

For the term of this contract, under the direction of the Embassy of Japan, Orion Strategies LLC will provide advice and consulting services concerning the Japan's strategic goals in the U.S.

Services pursuant to this agreement will include, but not be limited to, advice, guidance, and support for communications and public relations activities in the United States to assist the Embassy of Japan's efforts to achieve their strategic objectives.

#### **REPORTS**

Orion Strategies LLC will regularly provide the Embassy with detailed information in terms of the activities and findings regarding the above mentioned SCOPE, in writing and/or verbally.

#### **COMPENSATION**

During the term of this agreement, Orion Strategies LLC will be compensated at the rate of \$25,000.00 per month. As for the period from October 27 to 31, 2014, Orion Strategies LLC will be compensated at the rate of \$4,032.00. No additional expenses will be authorized unless approved in advance by the Embassy of Japan.

**PAYMENT**

Orion Strategies LLC will be paid in U.S. dollars by the Embassy of Japan on a monthly basis, with a payment of \$29,032.00 due on November 30, 2014 and payments of \$25,000.00 due on December 31, 2014, January 31, 2015, February 28, 2015 and March 31, 2015. Orion Strategies LLC will submit its monthly report prior to each Payment.

Payment will be rendered only after submission of an invoice by Orion Strategies.

**CONFIDENTIALITY**

Orion Strategies LLC agrees to take every reasonable step to prevent disclosure of any and all confidential information provided to it by the Embassy of Japan to third parties. Confidentiality shall extend to all information deemed confidential by the Embassy of Japan whether provided by or on behalf of the Embassy of Japan or developed by Orion Strategies LLC on its behalf.

**TERMINATION**


Termination of this agreement shall require thirty days written notice by either party.
