The registrant rendered government relations, political consulting and general diplomatic representation services to the Government of Japan in connection with congressional and U.S. Government positions, actions and legislation regarding Japan, the bilateral U.S. - Japan relationship, the San Francisco Peace Treaty with Japan of 1951, The Hague Convention on the Civil Aspects of International Child Abduction, and/or Japanese nationals, including corporations. Services by the registrant were coordinated, on behalf of the Government of Japan, by Hogan Lovells US LLP (FARA Registration Number 2244), a law firm representing the Government of Japan. Activities included communications with Members of Congress and their staffs.
