

Item 11 – ACTIVITIES

Embassy of the United Arab Emirates

Registrant conducted daily monitoring of US media outlets for news related to the United Arab Emirates. Registrant produced a daily compendium of relevant news clips for foreign principal. In addition, provided public affairs and communications counsel to help create a public diplomacy program. Registrant scheduled meetings and briefings for UAE Embassy staff with business people, academics, public policy groups and media.

Georgia

Registrant provided communications and public relations services to the Government of Georgia ("Georgia") as an independent contractor to Pillsbury Winthrop Shaw Pittman LLP). Registrant provided services to Georgia, both directly and indirectly through Pillsbury Winthrop Shaw Pittman LLP and others, on communications strategies and outreach activities dealing with US-Georgia relations, including economic and trade cooperation, security issues, NATO cooperation and EU integration. Registrant communicated with US and international media representatives about issues affecting US-Georgia relations.

Dominican Republic

Registrant assisted and supported the planning and execution of a communications program directed at US stakeholders. Program objectives were achieved through media monitoring, media relations support, message and materials development, and outreach to think tank analysts and academics.
