

12.A. Activities of Registrant on behalf of the Royal Embassy of Saudi Arabia

This corrects the description of the funding for certain advertisements set forth in the filings identified above.

Registrant assisted in the preparation, placement and press follow up regarding radio advertisements to promote a peace plan proposed by then Crown Prince Abdullah of Saudi Arabia. The scripts for the radio ads, which advised that they were paid for by the Alliance for Peace and Justice in the Middle East, were filed with the Department of Justice on April 29, 2002. In its December 13, 2002 filing Registrant stated that the Alliance had received permanent funding from the Council of Saudi Chambers of Commerce and Industry. Registrant has been informed that the Royal Embassy of Saudi Arabia provided to the Council of Saudi Chambers of Commerce and Industry the funds to pay for the advertisements.
