

Qorvis' agreement with the BNP is not the subject of a formal contract or exchange of correspondence. Qorvis has received no compensation for its services on behalf of the BNP. It is uncertain whether Qorvis will perform additional services for the BNP or will receive any compensation either for services it has already agreed to perform for the BNP or for any services it may perform for the BNP in the future.

The agreement thus far between Qorvis and the BNP is limited to Qorvis' dissemination of a single press release on behalf of the BNP.


