



III. Activities #11

For the Democratic Progressive Party, I attended conferences at the American Enterprise Institute, the Brookings Institution, the Carnegie Endowment for International Peace, the Council for Foreign Relations, the Center for National Policy, the Center for Strategic and International Studies, the Heritage Foundation, SAIS, the Sigur Center of GWU, the Stimson Center and the Woodrow Wilson Center to participate in discussions of US foreign policy with a focus on US policy toward both Taiwan and China.

I also attended Congressional hearings on US policy held by the US-China Economic and Security Review Commission and the Congressional-Executive Commission on China.

I held meetings with Administration officials, Members of Congress and their staff, think tank analysts, and reporters in the Washington area to discuss US policy toward Taiwan.

I sent regular reports on these activities to Hsiao Bi-khim, currently International Affairs Director of the Democratic Progressive Party, and to Hsieh Huai-hui, Deputy Director of the department.

Item #12 Meetings with US government officials, Members of Congress and their staff as well as the media:

3/15 Meeting with Frank Jannuzi, Keith Luce, Fulton Armstrong of the Senate Foreign Relations Committee staff. Dr. Joseph Wu and I updated the staffers on current developments in the Democratic Progressive Party and more generally political developments in Taiwan.

3/16 Meeting with Michael Schiffer, Deputy Assistant Secretary of Defense for Asian and Pacific Security. Dr. Joseph Wu and I updated Mr. Schiffer on DPP concerns about current defense issues in Taiwan and US arms sales to the island.

3/18 Meeting with Barbara Schrage, AIT Managing Director, Ted Mann Taiwan Desk Officer, Greg Man and Rick Ruzicka of AIT. Dr. Joseph Wu and I discussed the DPP's current situation, concerns about US-Taiwan relations and the DPP's position on US beef imports to Taiwan

3/18 meeting with Taiwanese reporters, including Nadia Tsao of the Liberty Times, Betty Lin of the World Journal, and John Zhang of CTI TV. Dr. Wu and the reporters discussed the current Washington views regarding Taiwan.

4/1 meeting with Barbara Schrage to get her views on current US-Taiwan issues and discuss developments in the DPP

4/3 Meeting with NSC Senior Director for China, Taiwan and Mongolia Jeff Bader and China Director Evan Medeiros. Ms Hsiao Bi-khim, the DPP's International Affairs Department Director and I reviewed the DPP's current thinking on China policy, cross-straits issues, and the DPP's sense of the current political situation. Dr. Bader updated us on recent issues in US-China relations vis-à-vis Taiwan issues.

4/4 Derek Chollet, the Principal Deputy Director of the Secretary's Policy Planning Staff. Hsiao Bi-khim and I reviewed DPP analysis of current cross-strait issues and the DPP's internal discussions of China policy.

4/4 Marta McLellan-Ross, Senator James Webb's staffer. Hsiao Bi-khim and I updated Marta on developments in the political situation in Taiwan, the DPP's views of Ma Administration policies, and asked Ms. McLellan-Ross about Senator Webb's perspective on US-China and US-Asia policy more broadly.

6/4 Barbara Schrage, AIT Managing Director. I met with Ms. Schrage to get a sense of current thinking in the Obama Administration regarding Taiwan and to update her on recent developments in the DPP.

8/12 Kurt Campbell, Assistant Sec. Of State for East Asian and Pacific Affairs and Nirav Patel, Senior Adviser, East Asian and Pacific Affairs. I updated Mr. Patel on current political developments in Taiwan and the progress of the DPP in coming back to life after a disastrous 2008 election cycle. Dr. Campbell joined us briefly and we discussed the current state of US-Taiwan relations. I updated them on my own trip to Taiwan in July.

8/13 JJ Ong, Rep. Howard Berman's staffer on the House Foreign Affairs Committee. I updated JJ on my July trip to Taiwan and political developments in cross-strait relations.
