

The firm has provided legal services to the Government of Chile since 1994 on the basis of our customary rates, with periodic contracts for legal services on particular matters. These services have only rarely involved FARA covered activities. We have re-registered because the conclusion and implementation of the Chile – United States Trade Agreement may involve limited contacts that require FARA registration. Such contacts, in accordance with our customary relationship with the Ministry of Foreign Affairs - Chile, would occur at the request of the Ministry and billed at customary hourly rates. There is no specific duration to this arrangement, though we can only perform services as and when directed by the Government of Chile.
