11. With respect to the Ministry of Finance and Industry, UAE, there were no political activities. Services provided were policy advice to federal government ministries regarding U.S. trade and investment law and policy, including advice regarding relationship between bilateral trade commitments and obligations in the World Trade Organization and regional trade agreements. No U.S. government officials or media representatives were present.

12. With respect to the Ministry of Finance and Industry, UAE, there were no political activities. No U.S. government officials or media representatives were present.

14. With respect to the Taipei Economic Cultural Representative Office in the United States, \$1,066.21 in travel and hotel/lodging costs were reimbursed by the client. The trip was taken by Marshall Harris, and included airfare and associated travel costs for a trip to California as part of a trip to Taiwan to meetings with the client. The airfare to Taiwan (in the amount of \$4302) and the hotel charges from the Taipei Hotel (in the amount of \$873) were paid directly by the client. No U.S. government officials or media representatives were involved in the trip. The trip occurred October 8 -16, 2006.

With respect to Montenegro, \$793.96 in costs associated with working meals were reimbursed by the client. These meals involved client meetings only and did not include any other parties. No U.S. government officials or media representatives were present.
