Under the Foreign Agents Registration Act definitions, all of the Tourism Ireland's activities in the United States could be considered disbursements in connection with activity on behalf of the foreign principal. While the total budget for the Irish Tourist Board includes salaries, travel, overhead, and other expenses, the marketing disbursements for this 6-month period were used for the production and dissemination of Ireland promotional materials.
