The Osaka University, San Francisco Office is an overseas university office representing, and wholly supported by, Osaka University in Osaka, Japan. The Osaka University, San Francisco Office was established in the United States in May, 2004 with the following proposed activities:

- i) establish English learning programs for students of Osaka University
- ii) implement and manage a distance learning program for students of Osaka University
- iii) organize and maintain a network for alumni of Osaka University in North America
- iv) organize foreign exchange programs for students of Osaka University in the U.S. and U.S. students at Osaka University
- v) support researchers of Osaka University who are in the U.S.
- vi) coordinate training of Osaka University staff in the U.S.

There has been no change to the above-listed activities to date.

Regarding a charter, articles of incorporation, association, and/or by laws for the Osaka University, San Francisco Office, there is no such documentation in existence to date. That is to say, this organization was established through the oral consent of Osaka University's president and its' council members, the council being comprised of deans representing every department at Osaka University in Japan.
