



After three months, upon discussion with Farragut Advisors EG (and others Farragut Advisors EG deems appropriate) of the requirements/standards identified and agreed upon, AHC agrees to undertake a comprehensive public relations and public affairs program in Washington, D.C. This will include, in general, educating and briefing the executive and legislative branches, think-tanks, NGOs, and international institutions; making personal introductions to Members of Congress and Administration officials; partnership building with U.S. agencies, NGOs, and the private sector; event organization; and media relations.


