



III – Activities

11. During this 6 month reporting period, have you engaged in any activities or or rendered any service to any foreign principal named in Items 7, 8 and 9 of this statement? Yes.

If yes, identify each such foreign principal and describe in full detail your activities and services.

I engaged in activities and rendered services to Idrissa Seck.

Mr. Seck is a former prime minister of Senegal. He is presently the leading opposition figure to the Senegalese government. In July 2005, he was detained in prison in Dakar, Senegal days after announcing that he was forming an opposition slate for the National Assembly elections. The detention was politically motivated. It lasted until February 7, 2006.

On April 4, 2006, Mr. Seck announced he would be a candidate for President of Senegal in the election scheduled for February 25, 2007.

During this six-month reporting period, I contacted staff of a member of the United States House of Representatives. I contacted the United States State Department desk officer for Senegal, the Charge d’Affairs at the U.S. Embassy in Dakar, and the United States Ambassador to Cote D’Ivoire.

The contacts with Congressional staff, State Department, and Embassy officials were by telephone calls and emails.

The content of the contacts included discussions of (1) a proposed visit by Mr. Seck to the U.S., (2) the oppressive conduct of the Senegalese government towards opposition figures, including Mr. Seck, and towards the press; (3) the conduct of the Senegalese elections on February 25, 2007; and (4) a visit by Mr. Seck to Cote d’Ivoire.

The purpose of the contacts was to request some of the contacted persons to meet with Mr. Seck to learn more about current Senegalese political, economic, social and human rights issues. The further purpose was to increase awareness of U.S. policymakers about abuses of power and violations of human rights by the Senegalese government and particularly about risk that the Senegalese government would not conduct full and fair elections in 2007. Among risks addressed was the silencing of opposition expression by media and by candidates through the oppressive use of police intimidation, unjust prosecution, jailing, and lawsuits.

12. During this six-month reporting period, have you on behalf of any foreign principal engaged in political activity as defined below?

I engaged in such political activity for Idrissa Seck.

My activity with staff of the United States Congress, State Department, and Embassies, was limited to that described in Item 11 above. This activity may be characterized as political in the sense that Mr. Seck was a candidate for President of Senegal in the February 25, 2007 election and the people I contacted were U.S. public officials. My contacts sought to influence U.S. policy towards Senegal in the following directions: (1) towards condemnation of political repression in the form of police intimidation, abusive prosecutions (particularly for treason and defamation), jailings of candidates and candidate staff, and lawsuits against the media and opposition candidates; (2) towards free and fair elections.

I did not arrange, sponsor or deliver speeches, lectures, or radio or TV broadcasts.
