For the registration period ending on February 29, 2008, please note the following:

I delivered an Oral presentation on October 6, 2007, regarding the legal status of the extradition case of Luis Posada Carriles at the Latino Congreso in Los Angeles California, as well as an oral presentation at the University of Baltimore Law School on February 4, 2008. I presented the authors, Ernesto Villegas and Alexis Rosas, of a book on Posada Carriles at the Caracas Book Fair on November 16, 2007. In so doing, I explained the present legal posture of the case. I also responded to various press inquiries regarding the extradition case. I did not issue press releases, nor did I make any press inquiries on my own. Dealings with the press were initiated by telephone calls from members of the press to me.

According to the terms of the contract, the government of Venezuela provided a flat total of \$14,000 per year for expenditures. During the registration period for this supplemental statement, I took several business trips related to the Posada Carriles case. One from October 5, 2007 to October 9, 2007 to Los Angeles for the purpose of making an oral presentation to the Latino Congreso. Another from December 15, 2007 to December 16, 2007 to Caracas, Venezuela for consultations with the Foreign Ministry, and one from November 8, 2007 to November 26, 2007, for consultations with the Foreign Ministry and the Office of the Prosecutor concerning the case.

During the registration period, including the aforementioned trips,, I did not meet with U.S. government officials, nor did I entertain members of the United States press corps. However, on November 13, 2007, I spoke three times by telephone from Caracas to Congressman William Delahunt (who was in Washington D.C.) regarding background information concerning the case of Luis Posada Carriles. Cong. Delahunt initiated the phone calls in preparation for Congressional hearings his committee was to hold several days later.
