

Because the registrant will be controlled directly or indirectly by the foreign principal, the registrant is filing under the Act. Work by the registrant will involve providing information to the Permanent Subcommittee on Oversight and Investigations of the Senate Committee on Homeland Security and Government Reform in connection with an inquiry into offshore financial institutions. 
