



SCHEDULE A

- I. The Consultant will provide to the Province an ongoing analysis of and commentary on the current evolving US Presidential Transition process.
- II. The Consultant agrees to provide research and intelligence to the Province, specifically with regards to policy interests in the following areas:
 - a) Energy and Climate Change
 - b) Transportation and Infrastructure

Within these areas, the Consultant will explore specific cross-border and regional initiatives with the potential to impact Saskatchewan's natural resources, international economy and cross-border positioning.

Additional analysis will include examination of the "lame duck" congressional session; news on decisions leading up to official appointments, as well as on the ground analyses of issues gaining resonance that could potentially affect Saskatchewan's interests.

- III. Based on these findings, the Consultant will suggest and, subject to the concurrence of the province, pursue specific actions designed to favourably position Saskatchewan's interests in Washington, D.C.
- IV. The Consultant will engage in a biweekly update meeting in the form of a conference call to be held at a mutually agreed upon time.
- V. The Consultant will advise the Province during visits to Washington, D.C. by government officials including, but not limited to the Premier of Saskatchewan, the Minister of Intergovernmental Affairs and others, as deemed appropriate.
- VI. The Consultant will meet and brief the Province's Premier, ministers and senior level officials regarding policy and transition issues in Washington, D.C.
- VII. At the discretion of the Ministry of Intergovernmental Affairs, the Consultant will visit Saskatchewan for the purposes of briefing Saskatchewan government officials on the evolving political and policy environment in Washington as this pertains to Saskatchewan's interests in the United States.
