VisitBritain's activities in the US are non-commercial and fit within the guidelines for the foreign government tourism bodies operating in the US as laid down by the member agencies of the US National Tourism Policy Council.

VisitBritain provides tourist information to potential tourists to Britain, the US media and the US travel industry. This is done through the use of travel websites, workshops, press familiarization trips, press releases and a limited amount of printed literature.
