Cayman Islands Extends Tax Information Assistance to 20 Countries, Including Major OECD Trading Partners

George Town, Grand Cayman – The Cayman Islands Government today announced that it now has in place arrangements that provide access to comprehensive tax information assistance with 20 countries, including the majority of Cayman's major trading partners.

Ireland, Japan, the Netherlands and South Africa now join eight other countries afforded tax information assistance to OECD standards under a unilateral mechanism, which does not require a bilateral treaty. The Cayman Islands also has eight bilateral tax information agreements, which include recent agreements with the Nordic countries as well as an existing agreement with the U.S. signed in 2001.

The unilateral mechanism, introduced in 2008, provides an additional mode for the Cayman Islands to deliver on its commitment to transparency and exchange of information in tax matters.

"The Cayman Islands took the proactive step of introducing the unilateral mechanism for the provision of information in tax matters, as a complement to our bilateral negotiation programme," said Cayman Islands Leader of Government Business, the Honourable Kurt Tibbetts. "We recognised the need to increase the pace at which we could enter into tax information arrangements, while offering a phased approach to our negotiating partners under our bilateral programme in appropriate circumstances. We look forward to continuing this progressive approach."

In combination, the arrangements noted above cover four of the seven G-7 states and 17 of the 30 OECD member states.

Based on its current negotiating programme – which reflects OECD countries (including significant trading partners) that have indicated interest in tax cooperation arrangements – the Cayman Islands aims in the following months to enter into arrangements with a number of additional countries, including the remaining G-7 and five other OECD member states.

Notes to Editors

- The Cayman Islands' eight bilateral tax information agreements cover the following countries: the United States, Denmark, Faroe Islands, Finland, Greenland, Iceland, Norway and Sweden.
- The Cayman Islands' unilateral arrangement for tax information assistance currently covers 12 countries, namely Austria, Belgium, Czech Republic, Germany, Ireland, Japan, Luxembourg, the Netherlands, Slovak Republic, South Africa, the United Kingdom and Switzerland.
- The Cayman Islands has been an active participant in the OECD Global Forum on Taxation, having been one of the first non-OECD jurisdictions to adopt (in 2000) the principles of transparency and exchange of information in tax matters, based on a level playing field. As an early adopter, the Cayman Islands has been involved in the development of the OECD's standards for effective exchange of information in tax matters and is a member of the Global Forum's level playing field sub-group, along with other OECD and non-OECD colleagues.
- In addition to arrangements under the OECD initiative, the Cayman Islands has bilateral tax treaties with the 27 EU member states under which it reports savings income information, pursuant to measures equivalent to the European Union Savings Directive.
- The Cayman Islands' competent authority for tax cooperation arrangements is the Tax Information Authority, established in 2005 under the Tax Information Authority Law (2005), the law introduced to provide for effective international cooperation in tax matters. Dear Mr President:

The success of the financial services sector in the Cayman Islands has been greatly enabled by the productive, long-standing and effective working relationships our two governments maintain on international cooperation efforts related to tax, regulatory and law enforcement matters. It is in this spirit of partnership with the United States that I am writing to you.

As the United States prepares to participate in next week's G-20 Summit in London, we want to ensure that the facts are taken into consideration. There is a good deal in the "jobs, growth, and stability" agenda of the meeting that merits attention and action, but we are acutely aware that the current public dialogue in relation to offshore financial centres risks both damaging those jurisdictions that play by the global rules and detracting from the substantive G-20 issues.

The Cayman Islands operates a financial services sector that, by any measure against global standards, is regulated, transparent and cooperative. The importance of our financial services industry to the continued economic stability of our country requires us to ensure we promote commercial certainty by upholding and supporting international standards.

We respectfully draw your attention to the following facts:

- The Cayman Islands' international cooperation arrangements with the United States include:
 - ~ A Mutual Legal Assistance Treaty (MLAT) signed in 1986 and in which our two governments have cooperated in some 243 matters on which the U.S. requested assistance, resulting in successful law enforcement actions. As a result, the U.S.

- Department of Justice has stated that the Cayman Islands is one of its best partners among offshore jurisdictions.¹
- ~ A tax information agreement signed in 2001 for civil and criminal matters.
 - ~ A memorandum of understanding on regulatory cooperation with the Securities and Exchange Commission as well as the Commodity Futures Trading Commission.
- The Cayman Islands was one of the first jurisdictions to commit to OECD standards for transparency and exchange of information in tax matters, and we hereby re-affirm that commitment. We have upheld it by working with OECD and non-OECD colleagues since 2000 to design effective standards, by reflecting those standards in our domestic regime, via the Tax Information Authority Law, 2005, and by embarking on a programme to extend assistance arrangements to other countries, the first being our tax information agreement with the United States. We have entered into tax information agreements with the seven Nordic Group countries and in 2008 introduced a unilateral mechanism for the provision of tax information assistance pursuant to which we have extended assistance to a further twelve OECD member states. We therefore now have 20 tax cooperation arrangements to OECD standards covering most of our major trading partners.
 - External assessors (IMF, CFATF, OECD) have repeatedly confirmed that there are no 'secrecy' bars to full compliance with international regulatory, AML/CFT and tax cooperation standards.²
 - The Cayman Islands' high level of compliance with FATF standards (38 ratings of 'compliant' or 'largely compliant' out of the FATF 40+9) puts us in the top five jurisdictions based on the 23 FATF third-round evaluations conducted to date. The Cayman Islands was the first CFATF country to include experts from FATF countries on its evaluation team (U.S. and Canada).
 - On international cooperation, under the Basel, IOSCO, IAIS and FATF standards, the Cayman Islands has been assessed as 'compliant' or 'largely compliant' or the equivalent (see footnote 1) and has also been accepted as a signatory to the IOSCO multilateral MoU. In fact, the Cayman Islands Monetary Authority (CIMA) has a statutory obligation under the Monetary Authority Law to cooperate with overseas regulatory authorities.
 - The Cayman Islands is one of the few jurisdictions to apply any regulation to hedge funds and hedge fund managers (including direct AML/CFT obligations); and in fact the registration requirement being contemplated by the G-20 has been in place in the Cayman Islands for many years. Any perceived lack of transparency in relation to hedge funds is referable to the state of international standards and not to any rules applied unilaterally by the Cayman Islands.

We appeal to the United States' sense of fairness and objectivity in relation to the treatment of partners like the Cayman Islands, particularly in fora where we have no direct voice. For those to whom facts matter (as we believe they do to you), a demonstrably strong compliance culture infuses our approach to running our international financial services sector and we are willing and able to work to international standards as they evolve and change, as we expect them to do.

We look forward to continuing to work with the United States and all of our international partners on an agenda that respects and promotes jobs, stability and growth for everyone.
