Ogilvy Public Relations Worldwide has been verbally awarded work with Proexport Colombia to provide media relations and communications support. The engagement is expected to be one year in duration and approximately \$220,000 in value.

Ogilvy Public Relations will provide strategic counsel around communications and public relations and will execute a media relations campaign to support tourism, foreign investment, and exports in Colombia.

The campaign will include activities such as establishing a proactive news bureau as a basis for conducting media relations activities and developing media opportunities; conducting events such as road shows, media breakfasts, and press trips to promote Proexport Colombia; identifying and engaging influencers; promoting and conducting speaking opportunities; and developing messages.
