The private sector entity (AMITH) pays SSA a set monthly fee for all services, and no additional fees will be charged to the Embassy for this work. Fees paid by AMITH to SSA are disclosed pursuant to the Lobbying Disclosure Act. It is anticipated that the work will be concluded within some months.
