**Privacy Act Statement.** The filing of this document is required for the Foreign Agents Registration Act of 1938, as amended, 22 U.S.C. § 611 *et seq.*, for the purposes of registration under the Act and public disclosure. Provision of the information requested is mandatory, and failure to provide the information is subject to the penalty and enforcement provisions established in Section 8 of the Act. Every registration statement, short form registration statement, supplemental statement, exhibit, amendment, copy of informational materials or other document or information filed with the Attorney General under this Act is a public record open to public examination, inspection and copying during the posted business hours of the Registration Unit in Washington, DC. Response to item #11.

Covington & Burling LLP will review documentation provided by the foreign principal and the Colombian Ministry of Agriculture and consult with relevant United States government agencies to ascertain the current status of the U.S. Department of Agriculture's approval process for the export of Colombian crops to the United States, in light of the obligations the United States may have under the U.S.-Colombia Free Trade Agreement. The crops include hass avocados, peppers, watermelon, melon, mango and beef. Following this analysis, Covington & Burling LLP will propose specific steps that Covington would take, working with the foreign principal, to achieve the foreign principal's market access objectives.
