Locke Lord Strategies (the registrant) assisted the Embassy in promoting legislation that would positively impact Pakistan, including HR 1886 Pakistan Enduring Assistance and Cooperation Enhancement Act of 2009, HR 1318 Afghanistan-Pakistan Security & Prosperity Enhancement Act of 2009, HR 2410 Foreign Relations Authorization Act Fiscal 2010 and 2011, S 496 Afghanistan and Pakistan Reconstruction Opportunity Zones Act of 2009, S 1707 Enhanced Partnership with Pakistan Act of 2009 by contacting US government officials and staff. The registrant also promoted support of the F-16 Mid-Life Upgrades and general issues concerning bilateral relations between the United States and Pakistan.
