On behalf of our client, we assisted with arranging a tour for the Emir of Qatar, Sheik Hamad bin Khalifa al-Thani of the areas in Louisiana and Mississippi devastated by Hurricanes Katrina and Rita. The Emir donated \$100 million to rebuilding the Gulf region. For this representation, we received fees of \$130,000 plus reimbursement of our expenses in arranging the visit.

We arranged for the Emir to visit areas devastated by Hurricanes Katrina and Rita. As part of this, we arranged for a helicopter and motorcade tour of parts of Louisiana, including New Orleans, as well as Mississippi. We arranged for meetings with Governors Jindal and Barbour, as well as with former President George H.W. Bush. We also provided the Emir with the opportunity for media interviews with various print and broadcast journalists.
