Effective September 1, 2010, the Republic of Gabon has agreed to pay BLJ the amount of \$100,000 for our public relations activities conducted on their behalf. BLJ will also be entitled to all expenses incurred as a result of this representation.

8. Describe fully the activities the registrant engages in or proposes to engage in on behalf of the above foreign principal.

We will engage in a public relations campaign on behalf of the Republic of Gabon in order for the country to position itself as a global green leader and to promote its business-friendly climate. As part of this representation, we will arrange large dinners at which VIP guests and global thought leaders can learn about Gabon, coordinate a media outreach campaign, and provide opportunities for the President and First Lady of Gabon to meet other leaders in politics and media.

If yes, describe all such political activities indicating, among other things, the relations, interests or policies to be influenced together with the means to be employed to achieve this purpose.

We will assist the Gabonese government in its efforts to reach out to the international political community through the United Nations and to the U.S. political and university community. We will accomplish this through editing and distributing press releases to our media contacts, as well as assisting with coordinating speeches and discussions by President Ali Bongo Ondimba and First Lady Mrs. Bongo Ondimba. As described above, the President and First Lady will be promoting Gabon's green initiative, its business-friendly climate, and working to bring attention to the plight of widows in Gabon.
