Princess Bint Al Hussein: Registrant provided counsel to foreign principal on issues related to health care, humanitarian work and sports, all outside the US. Registrant assisted with the preparation of a speech that was delivered at the James A. Baker Institute for Public Policy at Rice University in Houston, Texas. Registrant accompanied foreign principal to the Kelly Day Endowment on the Status of Women and Human Rights in the Middle East at the Baker Institute on June 9, 2011. At the event, foreign principal Princess Bint Al Hussein spoke about her work to end poverty and hunger.

Turkish Ministry of Foreign Affairs: Registrant performed international media outreach for briefing opportunities for the foreign principal as part of foreign principal's project supporting the UN Least Developed Countries conference. Briefings were intended to result in a news article prior to and in support of the conference.
