ENGAGEMENT AGREEMENT

Dated April 4, 2011

THIS ENGAGEMENT AGREEMENT (hereinafter referred as "Agreement") is entered into this April 4, 2011, by and between the Council of Ministers of Republic of Albania (hereinafter referred as CoM) having its principal place of business at Blvd. "Deshmoret e Kombit, No.1, Tirane, and PODESTA GROUP, (hereinafter referred as "the Provider") having its principal office located at 1001 G Street, NW, Washington, DC 20001.

WHEREAS, CoM wishes to have the Provider performing the services as below, and

WHEREAS, the Provider is willing to perform these services,

NOW THEREFORE THE PARTIES hereby agree as follows:

Legal basis

This Agreement will be based on article 7/d of law no. 9643, dated 20.11.2006, "On Public Procurement" as amended, and CoM decision no. 178, dated 11.3.2011.

Scope of Work

The Provider shall perform research services on advocacy issues that will serve in strengthening the ties between Republic of Albania and United States institutions. The Provider shall assist in fundraising from US and International agencies, as well as other services that may be agreed by the Parties in writing, (hereinafter referred as "Scope of Work").

Term

The Provider shall perform the Services during the period commencing in starting April 4, 2011, and continuing through March 31, 2012, or any other period as may be subsequently agreed by the parties in writing. The CoM shall review this Agreement every 6 months after it has been signed.

Payment

CoM shall pay the Provider an amount of US \$ 60,000 every month, plus expenses. CoM shall pay the Provider at the beginning of each three-month period, including the beginning of the term of this Agreement. The payment of the expenses shall be performed upon prior written consent of the CoM. Expenses for each three-month period shall be invoiced and paid with the fees due for the following period.

CoM's representative

CoM designates the Minister of Interior as its representative. The representative shall be responsible for the coordination of activities under this Agreement, and for acceptance of the deliverables by the CoM.

Performance Standard

The Provider undertakes to perform the services with the highest standards of professional and ethical competence and integrity.

Confidentiality

The Providers shall not, during the term of this Agreement and within two years after its expiration, disclose any proprietary or confidential information relating to the Scope of Work,

this Agreement or the CoM's business or operations without the prior written consent of the CoM.

Ownership of Material

Any studies, reports, opinions or other material, or otherwise, prepared by the Provider for CoM under the Agreement shall belong to and remain the property of the CoM. The Provider may retain a copy of such documents and software.

Insurance

CoM shall not be obliged to provide insurance under this Agreement. The Provider will be responsible for taking out any appropriate insurance coverage.

Assignment

The Provider shall not assign this Agreement or any portion of it without the CoM's prior written consent.

Governing Law and Language

The Agreement shall be governed by the laws of the Republic of Albania, and the language of the Agreement shall be English.

Termination

Both Parties may terminate the Agreement with at least 60 days prior written notice to each other. Payment for services shall be made through the date of the termination.

Amendment

This Agreement may not be modified or amended except by an instrument in writing by the parties hereto.

Miscellaneous

This Agreement is prepared in Albanian and English language and in 4 (four) copies, each of equal legal effect.
