Our activity as agent of V/K "NOVOEXPORT" was very limited and business operations were very small.

Since there is no written agent's agreement between the parties with a fixed rate of the commission, the amount of compensation will be determined between the parties later when Amtorg has performed more substantial work on behalf of its principal. We did not deem it necessary to charge an agent's fee for the small amount of effort we expended during the reported period.
