Registrant engaged in nonpolitical activity on behalf of the Government of Aruba by advising on developments affecting the economy of Aruba; by advising on matters related to Aruba's program on renewable energy; by assisting in the preparation and execution of a visit of the Prime Minister to New York City for meetings with the United Nations and investors, and by assisting with the preparation for the Prime Minister's interviews with media outlets in New York City to discuss Aruba's economy and vision for sustainable prosperity. Registrant also arranged for the Prime Minister to give lectures of a nonpolitical nature (Aruba's vision for sustainable prosperity) at New York University on March 26, 2014, and at The Earth Institute of Columbia University on March 28, 2014.
