- Bloomberg news interview for President Martinelli and Minister Vallarino on 9/22/10
- TV interview for Vice President Juan Carlos Varela on CNN en Español on 11/14/10.
- Bloomberg news interview for Minister of Commerce Henriquez on 11/18/2010.
- Wall Street Journal interview for President Martinelli and Minister Vallarino on 9/22/10


