This reporting period, that work included monitoring congressional issues and bills in relation to major U.S. foreign policies and assisting diplomats with daily tasks and research as requested.

Work also consisted in hosting a panel discussion hosted on Capitol Hill for congressional staff and community members; the coordination of and participation in the Embassy's US-Sri Lanka Parliamentary Exchange Programme in October 2011; and working with the business community to lobby the US Government.
