The organization hereby seeks to terminate its registration, effective 4/14/2011. The organization registered under FARA to ensure compliance in the event that it undertook activities that could be construed as falling within its terms. However, the organization has not undertaken any such activities and has no plans to do so. Nor does the organization have an agency relationship with a foreign principal: it is not under the direction or control of a foreign principal. While the organization identifies the Irish Labour Party as the object of its support, it is an autonomous entity, completely independent of the Irish Labour Party. For the avoidance of confusion, the registrant will not perform any activities that give rise to FARA registration requirements, regardless of what is set forth in any documents included with its initial registration. Nor will the organization create or maintain an agency relationship with any foreign principal.
