INSTRUCTIONS. Compliance is accomplished by filing an electronic short form registration statement at <http://www.fara.gov>.

Privacy Act Statement. The filing of this document is required for the Foreign Agents Registration Act of 1938, as amended, 22 U.S.C. § 611 *et seq.*, for the purposes of registration under the Act and public disclosure. Provision of the information requested is mandatory, and failure to provide the information is subject to the penalty and enforcement provisions established in Section 8 of the Act. Every registration statement, short form registration statement, supplemental statement, exhibit, amendment, copy of informational materials or other document or information filed with the Attorney General under this Act is a public record open to public examination, inspection and copying during the posted business hours of the Registration Unit in Washington, DC. Statements are also available online at the Registration Unit's webpage: <http://www.fara.gov>. One copy of every such document, other than informational materials, is automatically provided to the Secretary of State pursuant to Section 6(b) of the Act, and copies of any and all documents are routinely made available to other agencies, departments and Congress pursuant to Section 6(c) of the Act. The Attorney General also transmits a semi-annual report to Congress on the administration of the Act which lists the names of all agents registered under the Act and the foreign principals they represent. 

Footnote: Political activity as defined in Section 1(o) of the Act means any activity which the person engaging in believes will, or that the person intends to, in any way influence any agency or official of the Government of the United States or any section of the public within the United States with reference to formulating, adopting, or changing the domestic or foreign policies of the United States or with reference to the political or public interests, policies, or relations of a government of a foreign country or a foreign political party.

Question #11

This retroactive registration is being filed as of February 15, 2006, the date on which, to the best of Monitor's knowledge, it undertook registrable activities that were later reflected in the July 3, 2006, agreement filed with this registration. Over the eventual course of its work, Monitor's activities with respect to Libya sought to take advantage of a period of improved diplomatic relations and included the following: Monitor contacted and invited prominent international leaders, including in the United States, to visit Libya for meetings with officials of the government of Libya. Monitor created education and information programs about the United States political system. Monitor identified leading figures in the government, media, and academic communities, including in the United States. Monitor supported and conducted public relations on behalf of Libya, including distribution of materials in the United States and support of a public relations firm's outreach to journalists in the United States. Monitor's review of its activities in Libya is ongoing, and it will supplement this description as appropriate in a subsequent, supplemental disclosure statement.
